As may be available and at no additional cost to the member, weekly share boxes may be supplemented with certified organic vegetables and fruits or other agricultural products locally sourced and of the same high quality as you have come to expect from Grassroots Farm.

My Agreement

I want to participate as a summer share seasonal subscription member in the 2012 CSA Program at Grassroots Farm, LLC. By submitting this form I accept all conditions and terms of this program, which are:

1. As a subscription member I fully accept sharing the risk of crop failure from all factors beyond the farmer's control, knowing that it may affect the availability of certain crops and the amounts that I will receive throughout the season.

2. As a subscription member I fully accept sharing the rewards of a bountiful season and the adventure of receiving a wide variety of certified organic, locally produced food products, some of which may be procured off farm, but all of which will meet the Grassroots Farm quality standard.

Program and Payment Information

Please tell us which seasonal share programs you would like below:

- Summer share - 18 weeks of a 5/9 bushel closed carton delivery is \$540.00, tax included, when paid in entirety. Payment of the total cost of the subscription guarantees 18 weeks of delivery as above. Delivery dates correspond with the Andersonville Farmer's Market and the sharebox pick up location is to be determined, but will be in a central Loop location.
- Fall Share - 6 weeks of a 3/4 bushel closed carton delivery is \$204.00, tax included, when paid in entirety. Payment of the total cost of the subscription guarantees 3 weeks of delivery as above. Delivery dates are the same dates as the Andersonville Farmer's Market plus one additional delivery the week AFTER the Market, location to be determined, but will be in a central Loop location.
- Bread Share - Each seasonal share above can be upgraded with a bread/bakery share selection for just an additional \$6.00 per week of the share.
 - Summer Bread/bakery Share 18 weeks \$108.00
 - Fall Bread/Bakery Share 6 weeks \$36.00
